

## AUTHORIZATION AND CONSENT TO DISCLOSURE OF LIMITED CONTACT INFORMATION

### SOMERSET AT WINDSTAR HOMEOWNERS ASSOCIATION, INC.

I (We) are all record owner(s) of a home in Somerset at Windstar operated by Somerset at Windstar Homeowners Association, Inc. ("Association"). Association is a "Homeowners Association: and as much is governed by Chapter 720 of the Florida statues (hereinafter the "Act"). The Florida Senate passed HB 1195 and became effective July 1, 2011.

*...Notwithstanding the provisions of this paragraph, the following records are not accessible to unit owners:*

*Social security numbers, driver's license numbers, credit card numbers, e-mail addresses, telephone numbers, emergency contact information, any addresses for a unit owner other than as provided to fulfill the association's notice requirements, and other personal identifying information of any person excluding the person's name, unit designation, mailing address, and property address.*

The aforementioned protected information is hereinafter referred to as "Protected Personal Identifying Information". I(We) understand that the Association publishes various media in connection with the operation of the Association, which might presently, or in the future, include, but shall not be limited to, newsletters, websites, directories, message boards and "blogs" (hereinafter "Association-Related Media"). I (We) understand that in order for me (us) to participate in the publication and utilization of Association-Related Media, that it is necessary for the Association to obtain, utilize and publish certain limited Protected Personal Identifying Information, specifically telephone numbers (land line or cellular phone), e-mail addresses and addresses other than my(our) address in the condominium (hereinafter "Contact Information"). By signing this document, I (we) hereby authorize and consent to the Association's use and publication of Contact Information (but not other Protected Personal Identifying Information) in connection with Association-Related Media, further provided that such consent shall specifically not include social security numbers, driver's license numbers or credit card numbers. I (We) understand that other members of the Association, as well as third parties who may not be members of the Association, may easily and readily obtain access to my(our) Contact Information because of my(our) participation in the Association-Related Media. I (We) hereby consent to the utilization of Contact Information in connection with Association-Related Media and hereby covenant to make no claim against the Association (nor its officers, directors, agents or employees) in connection with the Association's publication of Contact Information. I (We) understand that but for the execution of this consent form, I (We) would not be entitled to have certain information which we otherwise wish to be made known published in Association-Related Media. Permission granted to the Association herein may be revoked in a

writing signed by all Owners of the unit and deposited in the United States Mail, certified, return receipt requested, and addressed to the official mailing address of the Association per most current recent records of Florida's Secretary of State, Division of Corporation. Such revocation shall be effective (10) working days after receipt by the Association as evidenced by the signed receipt card.
